Housing (Item 3)

- <u>Presentation about the Housing Equalities Group</u> from Dan Green, Housing Strategy and Policy Team, Sheffield City Council will be available to download from <u>meeting's webpage</u>.
- 2,300 new houses planned over next 5 years built to Lifestyle homes standard.

- Very small supply of accessible housing, need to increase in new <u>Sheffield plan</u> including housing for independent living.
- Critical Friend to Sheffield Housing Company
- Feed housing issues from groups/organisations including any barriers in accessing suitable housing
- 5-6 Housing Equalities Group (HEG) meetings per year: Issues raised by HEG members and policy officers – in future would like to add issues raised by all Hubs. Jake Green attends on behalf of Disability Sheffield/Disability Hub.
- **Comment**: Val Bowen, Information Officer at Disability Sheffield, attended HEG meeting previous week to give presentation on service users' experiences of rehousing. Council Officers are looking into the issues highlighted and taking follow up action which will benefit all disabled people.

- Sheffield has been awarded housing zone status
- Role of Council's Community support workers
- Comment: Sharon Brierley, Belong Day Centre Service Manager, gave example of her client waiting 5 months for an emergency review before ball can even start rolling to look for suitable housing.
- Comment: Accommodation centred on physical disability and access issues, other groups not getting same quality of housing and marginalised in unsuitable accommodation, e.g. exoffenders.

- New centralised system for awarding priorities
- Accommodation Plan for people with learning disabilities
- University of Sheffield suite of design guidelines for independent living
- Ex-offenders recognised as priority group in homelessness strategy (going to Cabinet in Jan 2017)

• Get Yourself Active is a partnership led by Disability Rights UK and funded by Sport England measuring impact of their work through asking disabled people who are getting active about the following areas of their life:

- o Confidence
- Independence
- Community involvement
- Physical and mental wellbeing
- They want to increase the number of people involved. Disability Sheffield is helping to
 recruit anyone who receives (or knows of anyone who receives) a direct payment and uses
 it to take part in any leisure activities who would complete a small survey before, at 6
 months and at 12 months about their experiences. Disability Sheffield is also encouraging
 social workers in the city to include leisure activities as an outcome in people's support
 plans.

Independent advocacy - Free Voice, Update on Event

Transport - Transport4All - Discussion on taxi services

- A number of members expressed their concerns about the safe transport of disabled people, particularly wheelchair users in taxis and the handling of complaints, building up a picture of regular bad practice by Sheffield City Taxis (the main provider in the city).
 Charging for accounts and the cost of having an account for Inland Revenue purposes was also raised. This issue has also been discussed at Sheffield Transport 4 All (T4A).
