


WHY SHOULD I TAKE PART IN TRAINING?

Engaging in training and further education around your role as an employer or a Personal Assistant not only develops your personal and professional skills, but also makes you more attractive to potential employers or Personal Assistants.

Attending training as a Personal Assistant can help you to better support your Employer in the way that they require. Having a good understanding of the best practice for a particular task will make you more confident when carrying it out, and will make your Employer more confident in your ability to support them.

Individual Employers benefit greatly from attending training or further education. Being a well trained employer helps you to better support your Personal Assistants and helps you to make sure your Personal Assistants are following best practice in their work.

Whether you've been in your role for a few weeks or a few years, it's always worth taking the time to improve your confidence, knowledge and skills. Being a well trained Personal Assistant or Individual Employer benefits yourself and the people you work with.

This Training Directory includes information on a wide range of topics, with courses and resources to suit you whether you have time to attend an person training session, or you want to take the time to learn from home. There are free sessions, paid sessions, videos, training resources and online classes available; available, so however you like to learn there's an option for you.



HOW TO REQUEST TRAINING IF YOU HAVE A PERSONAL HEALTH BUDGET

If you have a Personal Health Budget (PHB) then Personal Assistant training needs will be identified through discussions with the employers and any relevant clinicians when setting up the PHB and advice will be given on how the training can be accessed. Employers can discuss any further training requirements as they arise with the nurse assessor.

All PHB's will be reviewed 3 months after commencing and then on an annual basis, this will include reviewing training needs. Employers can request earlier reviews if required.

If you are an adult with a Personal Health Budget then all identified PA training needs are recorded in your Personalised Care Plan where resources have been identified based on what was available at that time.

Personal Assistants who wish to work for Deaf Employers will require BSL training, and have the ability to speak BSL at Level 2 or 3. BSL is widely taught throughout the UK, and courses starting from Level 1 are available at places such as:

- Famlingo BSL levels 1 & 2, as well as BSL GCSE and BSL for early years
- DeafAccess BSL Levels 1, 2, 3 and 6
